I can't believe it has been almost ten years since I was first elected President. I want to thank you all for having faith in me over these years.

A number of improvements have been implemented. *The Veteran* under Mike Keating has undergone a magnificent transformation and is now an award-winning newspaper, for which we are very proud.

Our Membership Department has gone through changes, but thanks to our IT consultant, Ms. Frankie Pressley, and our staff, along with our Membership Affairs Committee and National Secretary Bill Meeks, more improvements are on the way as technology enables our members to renew online as well as allow Membership chairs to access their membership list in real time.

Our lobbying effort was enhanced by our officers and my new Special Advisor, former National Treasurer Jack McManus.

The Finance Department, the Administration Department, the IT staff, and our Household Goods Program also keep our organization running efficiently. I want to thank them for their efforts.

Our Communications Department, headed by Mokie Porter, has brought us into the digital era with Facebook, Twitter and other outlets, while getting our message out to the print and video media.

The Veterans Health Council and its web site, www.veteranshealth.org, has been a great success. Tom Berger has been able to work with many health care affiliates to inform them about the health problems faced by veterans. I am proud to have been able to solicit donations to support this valuable program, especially from the Fisher Brothers Foundation.

Over the last two years the Officers have complemented each other, enhancing our operations. Secretary Meeks keeps our meetings and records in order and has been busy working with Chapters and State Councils to mitigate any disciplinary

problems. Treasurer Reynolds has worked with several Chapters and State Councils to insure that their finances are in order, while keeping our contracts in order.

Vice President Four has been a great addition. She works closely with the staff and was a great ambassador to Vietnam with our Veterans Initiative trip. She coordinates our Strategic Working Group on VVA's Future, including our Service Representatives' operations.



I am assigned the task of working closely for oversight of our Information Technology and Finance Departments. We have streamlined our financial reporting to make it more understandable and to reflect actual expenditures.

I have also been active in using my contacts in Congress to promote legislation that will assist veterans. The Agent Orange commitment from VVA has increased, and I have been an active Congressional lobbyist for VVA and our Agent Orange Legislation. We have increased VVA's financial commitment to AO.

I have been able to assist Regional Directors and State Council Presidents by making presentations at their meetings. I am available to assist at all levels of VVA.

VVA SERVICE: Life Member of VVA. I served 3 years as President of Chapter 511 and have been Alabama State Council President for 17 years. I was also the National Treasurer from 2001 to 2003. 




ship Committee and currently serving as National At-Large Director


